### Question 2

What's the difference between capacity dimension and correlation dimension?

- Capacity dimension measures the number of boxes needed to cover the points in a set, whereas correlation dimension measures the clustering of those points.
- Calculating correlation dimension is much slower than calculating capacity dimension.
- Both of them measure exactly the same thing; the only difference is the algorithm used to calculate them.
- Sauer et al. proposed the correlation dimension, whereas Grassberger and Procaccia proposed the box-counting dimension.

### Question 3

Consider the following image of a step in the calculation of the capacity dimension of the Julia set that was discussed in this unit:



What is  $N(\epsilon)$  in this image?

**Question 4**

**Question 6**

When calculating capacity dimension, why does the curve on a plot of  $\log(N(\epsilon))$  flatten out for high values of  $\log(1/\epsilon)$ ?

- Because one  $\epsilon$ -ball is covering the whole set.

- Because there's a power-law relationship between these two quantities.

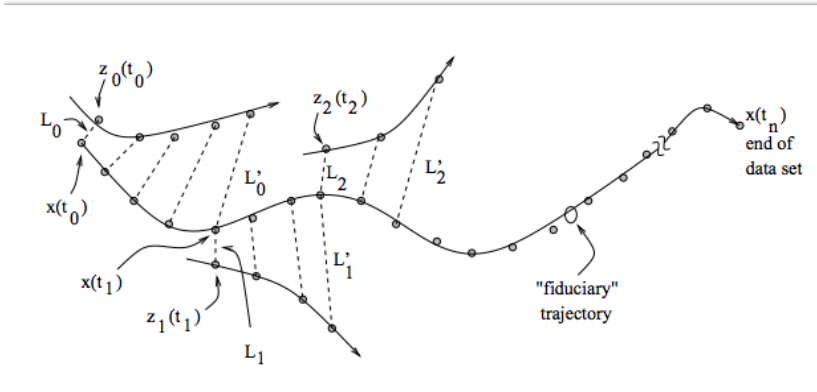
**Question 8**
